# PEMBROKE CITY COUNCIL MINUTES JANUARY 8, 2024

The regular meeting of the Pembroke City Council was held on Monday, January 8, 2024, at the J. Dixie Harn Community Center with the following members present: Mayor Judy Cook, Mayor Pro-Tem Tiffany Zeigler, Councilmembers Diane Moore, Karen Lynn, Ernest Hamilton, Johnnie Miller, Council Elect Sharon Lewis, and Council Elect Ed Bacon. Also, present were City Administrator Chris Benson, City Attorney Dana Braun, and City Clerk Arlene Hobbs.

**CALL TO ORDER, INVOCATION AND PLEDGE...** Mayor Cook called the meeting to order at 7:00 pm; Pastor Lawrence Butler of the Bridge Church gave the invocation. The pledge of allegiance to the flag was led by Mayor Pro-Tem Zeigler.

**MINUTES...** A motion was made by Tiffany Zeigler and seconded by Johnnie Miller to approve the minutes of the December 11, 2023; regular council meeting as presented. The motion carried unanimously.
