# Minutes of Planning & Zoning Commission Meeting of 11/2/23

**Call to Order:** Chair Bacon called the meeting to order at 6:30 p.m. Commissioners in attendance were Charlotte Bacon, Chair, Anne Barton, Vice Chair, Dave Williams, and Van Redcross. Shalah Beckworth was absent. City staff in attendance was Steve Scholar.

Approval of October 5, 2023 Minutes: Motion to approve the minutes made by Dave Williams, seconded by Van Redcross, all in favor, minutes approved.

### **PUBLIC HEARING:**

Chair Bacon opened the hearing to take public input regarding a conditional use application made by Aaron Thomas regarding a home occupation permit to operate a home office at 199 Harn Street, Parcel 02-03-012-01, property is zoned R-1.

Chair requested any speakers to come forward. Neither the applicant nor any members of the public were present to speak in favor or opposed.

The Commission members received information from Mr. Scholar provided by the applicant about the use being office only for a mobile mechanic business with truck that would be present at the site but offsite on calls for any work. There is no intention to bring motor vehicles to the home address for repairs at any time. All repairs will be done off site.

All other zoning requirements were met in the application submitted.

Motion to recommend to City Council the approval of the application based on the application meeting all zoning requirements by Dave Williams, seconded by Van Redcross, all in favor, motion passes.

Comments: It was noted that the new Family Dollar and Dollar Tree are completing their stock-up and should be completed and ready to open near end of October.
