# PEMBROKE CITY COUNCIL MINUTES OCTOBER 16, 2023

  The motion carried unanimously.
- 2. Approval of site plan for Huddle House restaurant on W. Bacon Street, parcel 01-03-007. Property zoned B-3, 0.44 acres. Planning commission recommends approval Travis Chassereau inquired if Smith and Thigpen streets would be paved as a part of the construction. Only the portion of the street going into the restaurant will be paved at this time. A motion to approve was made by Tiffany Zeigler, seconded by Johnnie Miller. The motion carried unanimously.
